# GENERAL PROCUREMENT NOTICE 3.0 MILLENNIUM CHALLENGE ACCOUNT NEPAL (MCA-Nepal)

# Published date: 08 February 2019

The Millennium Challenge Compact between the United States of America, acting through the Millennium Challenge Corporation ("MCC"), and the Government of Nepal (the "Government" or "GoN)) signed on September 14, 2017 (the "Compact") sets forth the general terms on which MCC will provide assistance of up to Five Hundred Million United States Dollars (US\$500,000,000) ("MCC Funding") to the Government for a program to reduce poverty through economic growth in Nepal (the "Program"). The Compact includes an additional investment of US\$130 million from the Government, for a total of approximately US\$630 million. The Government intends to apply parts of the proceeds of the funds to payments for contracts for goods, works and services to assist the Government with the implementation of the Compact program in a transparent and sound manner.

The procurement program for the next 11 months will include the following:

**PROCUREMENT OF CONSULTANCY SERVICES** (but not limited to):

- **Contract firms for consultancy services** related, (but not limited to): Engineering Designs/ESIA/RAP for Pilot Works; Technical Assistance for Road Management System; RAP Implementation; Construction Supervision; SGIP Development and GSI Training; Recruitment Services Options A and B (Sole Source Selection); Legal Consultant, External Audit Services.
- **Contract individuals for consultancy services** related, (but not limited to): Bid Review Panel and Technical Evaluation Panel Members (BRP/TEP Members); Senior Policy Advisor.

**PROCUREMENT OF WORKS** (but not limited to): Recycling Pilot Works.

**PROCUREMENT OF GOODS (including IT software)** (but not limited to): Asphalt Testing Equipment; Cement Stabilization Testing Equipment; IT Equipment (Computers, Drafting Tables, Printers, Specialized Software, Laptops, Monitors, Docking Stations, etc.); Falling Weight Deflectometer (FWD) with Accessories and Vehicle; MIS Infrastructure and Services for MCA-N Phase 1 and 2 (Direct Contracting); SAP Management Information Services and Related Services (Direct Contracting); Document Management System; Audio visual Conferencing System for OMCN, Drop-Box subscription (Direct Contracting).

**PROCUREMENT OF NON-CONSULTANCY SERVICES** (but not limited to): Office Maintenance and Utility Services, House Keeping Services.
