### 5. AGENDA ITEMS AND BOARD'S DECISIONS/RESOLUTIONS

#### A. Agenda One: Approval of Contract Amendments

#### I. Contract amendment of MCA-N/ETP/QCBS/006 - Consultancy Services for Construction Supervision for Transmission Lines and Substations Activities for Electricity Transmission Project (Contract with WAPCOS Limited, India)

5.1. The contract amendments are for the approval of Board of Directors as per MCC Program Procurement Guidelines (PPG) P4.1.1 and as per Section 2.9 Program Implementation Agreement. The Contract amendments are requested for: *MCA-N/ETP/QCBS/006 - Consultancy Services for Construction Supervision for Transmission Lines and Substations Activities for Electricity Transmission Project* and for *MCA-N/ETP/LCS/001 - Forest Census and Field Verification*.

5.2. MCA-Nepal has entered into a Contract to procure Consultancy Services for Construction Supervision for Transmission Lines and Substations Activities for Electricity Transmission Project (MCA-N/ETP/QCBS/006) on 29 September 2022.

5.3. After the completion of the evaluation and negotiations of the submitted technical and financial proposals, the Parties agreed to amend the contract by adding the additional scope of Services with an additional cost. This Amendment is expected to start immediately after the signing of the amendment of the Contract.

5.4. The Board of Directors RESOLVED that the Board provides in principle concurrence on assigning additional works based on the necessity. The Board recognizes that allocated budget is already available. On the Contract price amendment, after utilizing of this, it should be presented to the Board as per the MCC Procurement Guidelines. Based on it, the Board instructed MCA-Nepal to expedite the contract amendment and activities under the amended contract.

#### II. Contract amendment of MCA-N/ETP/LCS/001- No Cost Extension of Consultancy Services for Forest Census and Field Verification

5.5. MCA-Nepal has entered into a Contract to procure Consultancy Services for Forest Census and Field Verification (MCA-N/ETP/LCS/001) on 27 February 2023. The contract would expire on 12 January 2024. Given the current status of the work, the Contract needs no cost extension till end of May 2024.

5.6. In this regard, for the Extension of Consultancy Services Contract for Forest Census and Field Verification (MCA-N/ETP/LCS/001), the board instructed MCA-Nepal Executive Director to make necessary decision based on delegation of authority.

### B. Discussion on alternatives and options for expediting transmission line bids

- 5.7. Transmission line 315 km alignment was divided in 3 lots, and bids were invited on these three lots: Lot 1: Lapsiphedhi-Ratmate-Hetauda, Lot 2: Ratmate- Damauli and Lot 3: Damauli-Butwal and Butwal to- Border (18KM) as an option.
- 5.8. Technical bids were opened on 22 May, and Financial Bids were opened on 5 September 2023. Lot 3 contained cross-border 18 Km section that was put as an Option. Bids for all lots were rejected after MCC's recommendation on October 10 citing "substantially higher bid prices" as per PPG including that of Lot 3 and the X-Border Option in it.
- 5.9. In this circumstances, with the realization that the cross-border transmission line bids need to be expedited; the Executive Director presented to the board various alternatives to expedite the cross-border section of the transmission line. The Executive Director informed the Board that MCA-Nepal will soon seek formal written approval from MCC on the best alternative option for expediting the said section. Upon receipt of MCC response, the Executive Director will present the most suitable option for expediting the cross-border 18 Kms Line to the Board for Board's information.

### 6. RECORDING OF THE DISCUSSIONS AND DECISIONS

- 6.1. RESOLVED THAT the Board of Directors directs the Executive Director to record these minutes with the minute book of Millennium Challenge Account Nepal and to submit the synopsis of such minutes for publication on the website of Millennium Challenge Account Nepal within two (2) weeks from the date of signing of these Minutes.
