GENERAL PROCUREMENT NOTICE 2.8 Office of Millennium Challenge -Nepal (OMCN)

Published date: 17 August 2018

The Millennium Challenge Compact between the United States of America, acting through the Millennium Challenge Corporation ("MCC"), and the Government of Nepal (the "Government" or "GoN)) signed on September 14, 2017 (the "Compact") sets forth the general terms on which MCC will provide assistance of up to Five Hundred Million United States Dollars (US\$500,000,000) ("MCC Funding") to the Government for a program to reduce poverty through economic growth in Nepal (the "Program"). The Government intends to apply parts of the proceeds of the funds to payments for contracts for goods, works and services to assist the Government with the implementation of the Compact program in a transparent and sound manner.

This is an update of the General Procurement Notice (GPN) published on 12 December 2017 and 11 February 2018.

The procurement program for the next 4 months will include the following:

PROCUREMENTS FOR December 1, 2017 to December 31, 2018

PROCUREMENT OF CONSULTANCY SERVICES

- **Contract firms for consultancy services** related, (but not limited to): Engineering Designs/ESIA/RAP for Pilot work; Technical Assistance for Road Management System; RAP Implementation; Construction Supervision; Consultant SGIP Development and GSI Training; Project Management Training and Support.
- Contract individuals for consultancy services related, (but not limited to): Bid Review Panel and Technical Evaluation Panel Members (BRP/TEP Members); Soils Stabilization and FDR expert; Superpave Asphalt Mix Design and Rehabilitation Expert; Bid Challenge Second Level Appeal Pool of Consultants.

PROCUREMENT OF WORKS (but not limited to): Recycling Pilot Works.

PROCUREMENT OF GOODS (including IT software) (but not limited to): Asphalt Testing Equipment; Cement Stabilization Testing Equipment; IT Equipment (Computers, Drafting Tables, Printers, Specialized Software, Laptops, Monitors, Docking Stations, Printers, etc.); MIS Infrastructure and Services for MCA-N (Direct Contracting); Multifunctional Equipment/Printers (Direct Contracting); Audio visual Conferencing System for OMCN.

Contracts for Goods, Works and Services financed under the program will be implemented according to the principles, rules and procedures set out in the MCC Program Procurement Guidelines (PPG) which can be accessed on https://www.mcc.gov/resources/doc/program-procurement-guidelines. Procurements are open to all bidders from eligible source countries as defined in the guidelines (cited above).
