

SPECIFIC PROCUREMENT NOTICE

Request for Proposals for MCA-Nepal External Legal Counsel MCA-N/PM/QCBS/002

(Date of Publication/Place: 14 March 2019/ Kathmandu, Nepal)

- 1. This Request for Proposals follows the General Procurement Notice that appeared in Devbusiness.com and dgMarket on 7 February 2019, on the Himalayan Times newspaper on 13 February 2018 and was posted on the MCA-Nepal website https://www.mcanp.org/procurement/procurement-notices/ on 8 February 2019.
- 2. The Millennium Challenge Corporation ("MCC") and the Government of Nepal (the "Government" or "GoN") have entered into a Millennium Challenge Compact for Millennium Challenge Account assistance to help facilitate poverty reduction through economic growth in Nepal (the "Compact") in the amount of US \$500 Million ("MCC Funding"). The Government, acting through the Millennium Challenge Account Nepal ("MCA-Nepal"), a public institution established under the laws of the Nepal as the Accountable Entity for the Compact (hereafter referred to as the "MCA-Nepal"), intends to apply a portion of the MCC Funding to eligible payments under a contract ("Contract") for which the Request for Proposals ("RFP") is issued. Any payments made under the proposed Contract will be subject, in all respects, to the terms and conditions of the Compact and related documents, including restrictions on the use of MCC Funding and conditions to the disbursements of MCC Funding. No party other than the Government and the MCA-Nepal shall derive any rights from the Compact or have any claim to the proceeds of MCC Funding.
- 3. The MCA-Nepal hereby invites law firms authorized to offer legal services in Nepal to submit proposals for the following services: **MCA-Nepal External Legal Counsel**. More details on the services are provided in the Terms of Reference found at Section 5 of the RFP.
- 4. A law firm ("External Legal Counsel", "External Counsel", "Counsel" or "The Consultant) will be selected under the Quality and Cost-Based Selection ("QCBS") method as defined in the August 2015 version of the MCC Program Procurement Guidelines, which are provided on the MCC website https://www.mcc.gov/resources/doc/program-procurement-guidelines.
- 5. This invitation is for a fixed **rate** contract payable in United States Dollars. **The term** of the Contract would include a period to cover the Base Period of 12 months ending 30th June 2020; a first Option Period to cover the twelve (12) months ending 30th June 2021; a second Option Period to cover the 12 months ending 30th June 2022; a third Option Period to cover the 12 months ending 30th June 2022; a third Option Period to cover the 12 months ending 30th June 2023; a fourth Option Period to cover the 12 months ending 30th June 2023; a fourth Option Period to cover the 12 months ending 30th June 2024; and a close-out Option Period to cover the remaining duration of the Compact, plus 120 days to cover the Compact's close-out. The MCA-Nepal shall determine at its sole discretion whether to exercise each Option Period regardless of the performance of the Consultant. The estimated budget to be allocated for these services is US \$50,000 (Fifty Thousand US Dollars) for the Base

Period. Subject to the availability of funds, the estimated budget allocated for the services delivered during each Option Period is also U\$50,000.

Moreover, web conference will also be conducted for Consultants who would prefer to participate electronically.
