The Millennium Challenge Account Nepal (MCA-Nepal) has received a grant from the Millennium Challenge Corporation (MCC) (the "Compact") in an amount of US\$500 million and intends to apply part of the proceeds toward payments under the contracts to be awarded for Pool of Senior Policy Advisor Consultants (Several Consultants).

MCA-Nepal invites proposals from eligible *individual consultants* to provide policy and technical advice consulting services support to MCA-Nepal in four key areas: (1) operation of the Roads Maintenance Project; (2) operation of the Electricity Transmission Project; (3) support for the environmental and social safeguards work under the Project's Compact; and (4) support for policy advice on general governance activities and Government of Nepal policy process.

Procurement will be conducted through the Individual Consultants procedures as specified in the MCC Program Procurement Guidelines (PPG), and is open to all eligible bidders or consultants as defined in the PPG.
