The Millennium Challenge Account Nepal (MCA-Nepal) has received a grant from the Millennium Challenge Corporation (MCC) (the “Compact”) in an amount of US\$500 million and intends to apply part of the proceeds toward payments under the contract to be awarded for “**Land Acquisition Expert - Two Positions**”.

MCA-Nepal invites the interested eligible consultants for submission of CV/qualifications and experience with financial proposal to provide the consultant services as “**Land Acquisition Expert - Two Positions**”.

#	Required Qualifications
1	Minimum Bachelor’ degree in any field, a Master’s degree will be an added advantage.
2	Ten years’ of general experience with at least 5 years experience in the field of land acquisition, compensation, rehabilitation, and resettlement planning and implementation associated with major construction projects of a similar nature.
3	Working experience with affected communities, people and local government line agencies and in rural areas.

4	Familiarity with international environmental and a social safeguard guidelines and policies of major donors, including IFC Performance Standards on Environmental and Social aspects.
