The Government of Nepal, acting through the Ministry of Finance (the “Government”) and the United States of America, acting through the Millennium Challenge Corporation (“MCC”), entered into a Millennium Challenge Compact on September 14, 2017, providing for a grant of up to FIVE HUNDRED MILLION United States Dollars (US \$500,000,000) to advance economic growth and reduce poverty in Nepal (the “Compact”), to which the Government will contribute up to US\$130,000,000 for a program to reduce poverty through economic growth in Nepal, and intends to apply part of the proceeds toward payments under the contract to be awarded for “**Consulting Services for Forest Census and Field Verification**”.

MCC’s funding is appropriated by the U.S. Congress and obligated to the compact up-front, with no incremental or partial funding. So, when a contract is signed with an MCA Entity, money is already available to the MCA Entity and, for most contracts, invoices are paid directly to Contractors/Consultants/Suppliers by the US Treasury.

MCA-Nepal now invites *proposals* from eligible *consultants* to provide consultancy services to provide Technical Assistance and Logistic Support during Forest Census activities of 400 kV D/C Electricity Transmission Line where the task comprises of:

1. Task I: Inception of the Assignment
2. Task 2: Arrangement of Logistics Needed for the Forest Census Team
3. Task 3: Technical Support during the Forest Census
4. Task 4: Stakeholders Consultations
5. Task 5: Preparation and Submission of Field Verification Report
6. Task 6: Preparation of Forest Clearance and Land Use Permit Application

Procurement process will be conducted through the **Least-Cost Selection (LCS)** method procedures as specified in the MCC Program Procurement Guidelines (PPG) and is open to all eligible consultants as defined in the PPG.
