The Government of Nepal, acting through the Ministry of Finance (the "Government") and the United States of America, acting through the Millennium Challenge Corporation ("MCC"), entered into a Millennium Challenge Compact on September 14, 2017, providing for a grant of up to FIVE HUNDRED MILLION United States Dollars (US \$500,000,000) to advance economic growth and reduce poverty in Nepal (the "Compact"), to which the Government will contribute up to US\$130,000,000 for a program to reduce poverty through economic growth in Nepal, and intends to apply part of the proceeds toward payments under the contract to be awarded for "Construction of Ratmate Boundary Wall (Chain Link Fence)".

MCC's funding is appropriated by the U.S. Congress and obligated to the compact up-front, with no incremental or partial funding. So, when a contract is signed with an MCA Entity, money is already available to the MCA Entity and, for most contracts, invoices are paid directly to Contractors/Consultants/Suppliers by the US Treasury.

MCA-Nepal now invites password protected bids with hard copy submission of bid security from eligible bidders for the **Construction of Ratmate Boundary Wall (Chain Link Fence).** The Works consists of the Construction of a Chain Link Fence and Gate at Ratmate Substation, Nuwakot.

Bidding will be conducted through the **Competitive Bidding** procedures as specified in the MCC Program Procurement Guidelines (PPG) and is open to all eligible bidders or consultants as defined in the PPG.

Bids must be delivered to the address below on or before 13:00 hours (local time of Nepal (GMT+5:45)) on 23 September 2022. Only electronic bid submitted via the below provided **Dropbox Link** with hard copy of bid security submission will be permitted; the bid security shall be submitted at the address below to the attention of the Procurement Agent. Late submission of bid or bid security shall be reason for rejection of the bid and the bid shall be rejected. Bids will be publicly opened in the presence of the bidders' designated representatives and anyone who chooses to attend at the address below on 23 September 2022 at 13:30 hours (local time of Nepal (GMT+5:45)). All bids will be accompanied by a *Bid Security* in the amount of NPR 280,000.00 and shall be submitted in hard copy before bid submission deadline.
