

The GOE Policy is an Important Eligibility Criteria

- 1. Part 13 of the Program Procurement Guidelines
- 2. No Government-Owned Enterprises (GOE) allowed to bid for goods & works procurements
- 3. The Process to Determine a Firm as a GoE is a MCC process
- 4. What is a GOE?
 - "Government-Owned Enterprise" or "GOE" is any enterprise established for a commercial or business purpose that is owned and/or controlled by a Government (whether directly or indirectly).
 - "Government" means one or more governments, including any agency, instrumentality, subdivision or other unit of government at any level of jurisdiction (national or subnational).
 - "Owned" means a majority or controlling interest (whether by value or voting interest) of the shares or other ownership interest of the entity is owned (whether directly or indirectly and whether through fiduciaries, agents, or other means).







Conflict Of Interest

- It is suggested to review ITB 5.8 to 5.13
- Those Provisions stablish the types of Conflict of Interest that may disqualify a bidder
- Government Employees
- Others

 - Participants shall cover all expenses for their participation in site visit
 - Participants to ensure their safe participation:
 - Covid Precautions
 - Personal Protective Equipment as applicable
 - Follow safety instructions to be provided by MCA-Nepal
 - In any case, MCA-Nepal is not liable for any incident during site visit
 - Follow common safety rules while visiting a Site
 - Park your vehicle in a safe place
 - Use high visibility cloth/jacket
 - Use a protective mask all the time
 - Keep safe distance from other as applicable
 - Always stay within the Group, don't explore by your self

SITE ACCESS

- Please Refer to section **5.6.4 stating MCA-Nepal Expectations of Contractor's Environmental and Social Planning in TL IFB Section V B0**. The contractor must comply all requirement before commencement of any site activity.
- The Employer will arrange temporary site access to the Contractor within Fifteen (15) days after the commencement in accordance with the temporary land access procedures defined in the ESHSMP
- The permanent access for the actual construction work will be granted in a phased manner. The schedule for permanent site access will be provided by the Employer, with assistance from the Engineer, based on the phased completion of the permanent site access protocol defined in the ESHSMP.
- The Contractor must adhere to the permanent access schedule while mobilizing construction teams for foundation and other work. The Contractor shall do their own calculations on how many shifts, if any, they shall work to complete the works on time and its corresponding costs.



REQUIREMENTS

- The Contractor can propose their own design but **the tower footprint and height of the tower** cannot be changed without approval of the Engineer.
- Transportation of Materials: No new road construction is allowed and the contractor should use the existing roads. However, the Contractor is allowed for improvement of the road without widening. The Contractor is also allowed for temporary lease hold of private lands for transportation of construction materials at their cost and time as defined in ESHSMP document (refer to-Section V/B0/Annex 10)
- Quad- Circuit Towers: Some sections like New Damauli to New Butwal, Ratmate to New Hetauda includes quad circuit towers, the bidder should consider those towers while preparing the bid.
- Aviation Lights: The SoW also includes marker balls, aviation lights with power supply arrangement.
- Bird Diverter and Guard: The SoW also includes bird diverter and bird guard.
- Live Line Maintenance: It must be considered while designing the tower design. (in terms of additional clearance)
- Tower Protection and Leg Extensions: Route alignment is in Hilly area which attracts the tower protection and leg extensions work in several locations, the bidder has to consider all these things while preparing the bid.



REQUIREMENTS

- Line & Road Crossing: Cost associated to crossing of any voltage level lines and all type of roads including arrangement for scaffolding and arrangement for power/traffic block is in the scope of Contractor. The bidder should consider the associated cost for power and traffic blocking.
- Long Span: Bidder has to consider
 - ✓ Major river crossings like in (Trishuli, Kaligandaki, Rapti, Seti) upto 800m (approx.)
 - ✓ Long spans (Hill to Hill) upto 1500m (approx.)
- Extra Height Tower: The bidders has to consider towers for crossings of 400kV, 220 kV and 132kV line crossing towers while preparing their bids. Tower height may goes upto 100m (approx.) or more.
- Conductor stringing: The contractor has to use Drones to minimize the tree clearance
- **Sign board and Branding**: Refer to section V/B0- Annex 4 MCA-Nepal Branding Guidelines. The bidder must consider the associated cost to comply the guideline in the annex 4. The signboard are required to be fixed at every 20km interval.
- Temporary site installation: While preparing the bid document the bidder must consider the associated cost to comply the Section V/B0/ 5.A 102.
- The Bidder has to submit both Price Schedule and Price Reasonability as a part of their bid document.



ESP-REQUIREMENTS

- ➤ MCA-N/MCC ESP Compliance is very stringent and is not like other regular projects. The Contractor has to set up their ESP team with resources and of international quality so that the ESP deliverables meet the employer's requirement.
- Consistent with MCC Environmental guidelines, IFC standards (PS 1-8) and National policies, all risks/impacts associated with construction/implementation of the project must be avoided, mitigated or compensated so that the construction activities cause minimal impact to the community, region or the country as a whole.
- Environmental Impact Assessment (EIA), Environment and Social Impact Assessment (ESIA), Environmental Social Health and Safety Management Plan (ESHSMP) and Environment Social Management System (ESMS) are important part of the of the TL IFB which identify all the impacts and mitigation measures associated with construction activities and linked cost implication.



ESP-REQUIREMENTS

The works shall include as a minimum, not-limiting to:

- The cost associated for the ESHSMP related works defined in ESHSMP BoQ attached as Annex 6A. The bidder must fill up the rates and other information required in the BoQ.
- ➤ MCA-Nepal's Expectation of Contractor's Environmental and Social Planning and Works and mitigation measures are defined in Section V/B0 of bidding document
- The Contractor shall develop Contractor's Environmental, Social, Health & Safety Management Plan (CESHSMP) before commencement construction activities.
- The cabinet approval for tree clearance will be obtained by MCA-Nepal. The Contractor will be responsible to obtain work permits from DFO and affected Community Forests User Groups (CFUGs), clearance of trees under the supervision of the office of DFO and CFUGs, transportation of felled trees to the designated area as determined by DFO and all other associated work as mentioned in IFB.



ESP-REQUIREMENTS

- The Contractors should prepare site specific communication, health & safety plan before commencement of each major activities. Appropriate PPE (Personal Protective Equipment) such as Safety Jacket, Helmet, Safety Boots, gloves, mask, etc. shall be used according to the nature of work, as and when required as per the Consultant's Project Specific Safety Plan requirements.
- Contractor will demonstrate a strong commitment to health and safety management in compliance with **OSHAS 18001:2007**.
- Contractors will have the responsibility to establish its temporary office and associated facilities, laydown areas and storage yards at appropriate locations consistent with its deployment and work performance strategy through lease / rent of land/establishment at their cost.
