#### **Opening Remarks:**

The Technical Offers (Bids) opening session was called to order by the Procurement Agent Manager. Upon welcoming the members present, he informed them that the purpose of the meeting was for them to witness the opening session of the Bids that were received. The Bids Opening session took place at Crystal Hall, Ground Floor, Lal Durbar Convention Center, Yak and Yeti Complex, Durbar Marg, Kathmandu, Nepal and online through Zoom from 13:00 hours (local time of Nepal (GMT+5:45)) on 22 May 2022, as per the Bid opening date and time stated in the Addendum #11 to the Bidding Document.

#### Introduction:

A total of six (6) Bidders submitted their Bids for this procurement (Refer: **Annex I**, Register of Bids Received) before the closing time of 13:00 hours (local time of Nepal (GMT+5:45)) on 22 May 2022. No late bid was received. No Substitution, Modification or Withdrawal requests were received.

#### Attendance:

The six Bidders were represented as follows: Mr. Santosh Reddy (Association of M/S Megha Engineering and Infrastructures Limited and M/S Power Mech Projects Limited), Mr. Lalit Saxena (Kalpataru Power Transmission Limited), -Mr. Nitin Gupta (M/S KEC International Limited, India), Mr. Prasad Bombatkar (Transrail Lighting Limited), Mr. Somu Chatterjee (Tata Projects Limited), Mr. Abhas Kumar Rai (Larsen & Toubro Limited). The Bidders were present with more than one representative. In addition, officials from MCA-Nepal, officials from MCC and officials from the Procurement Agent participated in the Bid Opening Session. #### **Proceedings:**

All parcels received from the Bidders were placed in the Crystal Hall, Ground Floor, Lal Durbar Convention Center, Yak and Yeti Complex, Durbar Marg, Kathmandu, Nepal visible to all participants. Participants were requested to verify that their bids were in the same condition as delivered. Parcels were received in conformity with the prescribed instructions in the Bidding Document and were opened in the presence of all online and present members. The sealed financial offers were also shown and kept unopened.

Pertinent details as per Section I, ITB 26 and ITB 22 (d) were readout and recorded in the Technical Proposals Opening/Bids Checklist, which is attached to these minutes as **Annex IV**.

#### Other Observations and/or Comments:

The bidders were informed that MCA-Nepal will proceed with the evaluation of the submitted proposals and will timely notify them of the results. It was also noted that the minutes of the Technical Offers Opening Session will be shared with the bidders and posted on the MCA-Nepal webpage. The Procurement Agent Manager also highlighted that the evaluation would begin shortly.
