#### OUTREACH UPCOMING PROCUREMENTS ELECTRICITY TRANSMISSION PROJECT

### Power Sector Technical Assistance to Electricity Regulatory Commission (ERC) and Nepal Electricity Authority (NEA)

- 1. The Federal Democratic Republic of Nepal, acting through the Ministry of Finance (the "Government") and the United States of America, acting through the Millennium Challenge Corporation ("MCC"), entered into a Millennium Challenge Compact on September 14, 2017, providing for a grant of up to FIVE HUNDRED MILLION United States Dollars (US \$500,000,000) to advance economic growth and reduce poverty in Nepal (the "Compact"), to which the Government will contribute up to US\$197,000,000 for a program to reduce poverty through economic growth in Nepal.
- 2. The Compact program includes investment from MCC of approximately US \$ 500 million and an additional US \$ 197 million from the Government, for a total of approximately US \$ 697 million. It includes two projects: (i) The Electricity Transmission Project (ETP) will manage the construction of about 315 km of 400 kV electricity transmission lines, three substations, and technical assistance for the power sector; and (ii) The Road Maintenance Project (RMP) will provide technical assistance to improve the road maintenance regime and road maintenance works on about 300 kilometers of the strategic road network. The program would include the procurement of contractors and consultants for design, construction and supervision of electricity lines and substations, road maintenance works, including a variety of technical services, equipment and construction works in different geographic locations within Nepal. These contracts will be competed through open international procurement procedures.
- 3. Power Sector Technical Assistance Activity aims to support the establishment of an independent electricity sector regulator (the Electricity Regulatory Commission or "ERC"), as well as capacity-building through technical assistance to help bring transparency, efficiency, and competition into Nepal's power sector. MCC Funding will be used to embed experts within ERC to improve ERC's skills in rule-making, dispute resolution, and economic and technical regulation. This Activity will also focus on helping the Nepal Electricity Authority ("NEA") improve its transmission business in the areas of regulatory cost recovery, improved grid operations, and better system planning.
- 4. MCA-Nepal, which oversees and manages the projects funded by the Compact, intends to organize two Outreach Events (in Kathmandu, Nepal and in New Delhi, India) with Consulting Firms Representatives to provide relevant information on the upcoming Procurements for Technical Assistance to ERC and Technical Assistance to NEA and share available updated procurement information, as applicable.
