# Pilot Road Recycling Project

### East – West Highway – Dhan Khola Lamahi Road Section (DLRS) Pavement Rehabilitation using Full Depth Reclamation, Soils Cement Stabilization and Superpave Asphalt

- 1. The Federal Democratic Republic of Nepal, acting through the Ministry of Finance (the "Government") and the United States of America, acting through the Millennium Challenge Corporation ("MCC"), entered into a Millennium Challenge Compact on September 14, 2017, providing for a grant of up to FIVE HUNDRED MILLION United States Dollars (US\$500,000,000) to advance economic growth and reduce poverty in Nepal (the "Compact"), to which the Government will contribute up to US\$197,000,000 for a program to reduce poverty through economic growth in Nepal.
- 2. The Compact program includes investment from MCC of approximately US\$ 500 million and an additional US\$ 197 million from the Government, for a total of approximately US\$ 697 million. It includes two projects: (i) The Electricity Transmission Project (ETP) will manage the construction of about 315 km of 400 kV electricity transmission lines, three substations, and technical assistance for the power sector; and (ii) The Road Maintenance Project (RMP) will provide technical assistance to improve the road maintenance regime and road maintenance works on about 130 kilometers of the strategic road network.
- 3. The Road Maintenance Project (RMP) program would include the procurement of contractors and consultants for design, construction, and supervision of road maintenance works, including a variety of technical services, equipment and construction works in different geographic locations within Nepal. These contracts would be competed trough open international procurement procedures.
- 4. MCA-Nepal, which oversees and manages the projects funded by the Compact, intends to organize an Outreach Event in Delhi, India with Construction Firms Representatives and other interested parties to provide relevant information on the upcoming Procurement for the East West Highway Dhan Khola Lamahi Road Section (DLRS) Pavement Rehabilitation using Full Depth Reclamation,
