The technical scores attained by the firms were read aloud. The financial offers were

opened one by one and Total Offer Price, as stated in the FIN-1 of the Financial Offers were read out aloud and recorded as per Instructions to Offers (ITO) 25.5 of the Request

for Offers (RFO). One Offeror has not mentioned the price in FIN-1 and thus the price stated under FIN-2 for this Offeror was read-out.
