#### IV. Welcome by Procurement Agent

The Procurement Agent Manager of the Procurement Agent of MCA-Nepal welcomed all the conference participants and provided a brief presentation about the objectives of the Pre-Offer Conference and agenda. He also highlighted the following points:

- (i) in case of any discrepancy between the presentations and the Bidding Documents or its Addenda, the Bidding Document and issued Addenda will prevail.
- (ii) The responses provided during this meeting are only draft answers. The minutes of the meeting will contain the responses in writing and that will be final.
- (iii) The prospective offerors are requested to submit all the queries/questions in writing.

#### V. Welcome Remarks by MCA-Nepal

The Deputy Executive Director Management of MCA-Nepal welcomed all participants, highlighted the importance of this procurement for MCA-Nepal related to the MCA Partnership Program for MCA-Nepal (a benefit sharing component). She also requested/encouraged to all the prospective bidders to ask all their queries in writing by the clarification deadline and MCA-Nepal will take the note of all questions and provide the answers.

#### VI. Presentation on technical aspects of Bidding Document

The Engineer–Transmission Line of MCA-Nepal provided a technical presentation with the information about project updates, project areas, base and option work locations, scope of works and project requirements, timeline, staffing and key personnel, stakeholders as well as KMZ files, drawing of construction standard and quantities of works.

The ESP Specialist and GSI Specialist of MCA-Nepal provided a brief description on the ESP requirements and the GSI requirements as well as critical highlights.

#### VII. Procurement Briefing on the Bidding Document (Procurement Presentation)

The Senior Procurement Specialist from the Procurement Agent of MCA-Nepal presented the Bidding Document, highlighting and emphasizing important provisions of the Bidding Document to avoid common mistakes in the Offer submission and where Offerors need to have a clear understanding to develop a sound Offer such as clarification deadline, submission deadline, procedure to submit/upload the Offer, qualification evaluation criteria and submission forms.

#### VIII. Question and Answers – Pre-Offer Conference

After the technical presentations, the participants of the bidders' representatives were provided the opportunity to ask queries/questions. The queries raised by the participants were responded by MCA-Nepal team comprise of technical, procurement and Procurement Agent team. It was informed that MCA-Nepal will provide the answers in writing for the queries in which there was no specific answers during the conference. The questions raised by the bidders' representatives and the responses provided by the MCA-Nepal team are presented in Annex B.

#### IX. Question and Answers - Extended Session

After the Lunch Break, the participants were given further opportunities to seek additional questions and clarification on the bidding document if any. Some of the bidders put their concerns regarding the requirement of Environmental and Social (E&S) Management Experience and Health and Safety (H&S) Management Experience, for which the request was to make these requirements softer and flexible. The MCA-Nepal team took note on this, and responded in the meeting that this concern will be discussed with the authorities and if approved, will be modified issuing an addendum to the bidding document.

The BoQ in the excel sheet format was also presented to offer guidance on how to complete it.

#### X. End and Closing Remarks

The Manager – Program Procurement of MCA-Nepal thanked all the participants for attending/joining the conference and for their active participations and requested to prepare the proper offer taking consideration to include the Environmental and Social (E&S) Management, Health and Safety (H&S) Management Experience, if they have such experiences. He also encouraged to request any clarification the prospective bidders might have so that MCA-Nepal will try its best to provide the answer as soon as possible. The Pre-Offer Conference was closed at 2:03 PM (Nepal time).




